After being reviewed by the finance and accounting committees, the draft federal Form 990 is reviewed and approved by the full Board of Directors prior to being remitted to Raffa, P.C. to finalize and electronically file with the Internal Revenue Service.

Explanation: The Board of Directors adopted an ethics and conflicts of interest policy. The Policy is provided to all leaders of SVA and must be filed annually. The Board of Directors monitors and enforces compliance violations.
